April 1, 2021	SCOTT MCAFEE BECOMES INSPECTOR GENERAL (AFTER DEB WALLACE)
September of 2021	JOE ROSSI WROTE LETTER TO GOV KEMP PROVIDING EVIDENCE OF FAKE DUPLICATE BATCHES IN THE OFFICIAL FULTON HAND COUNT TOTALS
November of 2021	GOV. KEMP WROTE A LETTER WITH ATTACHED REPORT OF THE ROSSI FINDINGS CONFIRMING THE WORK WAS ACCURATE AND ASKED SEB TO INVESTIGATE IT
